Founders' Privileges and Recognition

Founders Legacy Lifetime Corporate Membership

Founders receive Garland Mountain's most comprehensive and enduring membership level, designated as the Founders Legacy Corporate Membership. This lifetime membership tier is available exclusively through participation in the Garland Mountain Founders Club and is intended to recognize those who choose to support the club at this formative stage.

The Founders Legacy Corporate Membership is structured as a lifetime corporate membership, providing long-term continuity and protection from future changes to corporate membership structures or annual renewals. As Garland Mountain's facilities and offerings continue to expand, Founding Members are permanently exempt from annual dues, renewals, or future membership rate increases.

This membership extends preferred member pricing to accompanying guests, allowing up to twelve guests per visit to receive preferred rates, making it well suited for business entertaining, hosted gatherings, and family use.

Founders receive priority consideration across key areas of the club experience, including dining reservations, priority access to the cart fleet, and registration for select events and shooting opportunities.

Each Founding Member is issued up to six membership cards. Each cardholder may host guests under the Founders Legacy Corporate Membership privileges. To reflect the evolving nature of families and businesses, Founders may update designated cardholders once annually, offering flexibility beyond standard corporate membership arrangements.

Permanent Sporting Clays Station Naming

Founders receive permanent naming rights to a sporting clays station, marked by a professionally fabricated metal plaque bearing the Founder's business or Family name. As stations are limited, naming opportunities and preferred locations will be assigned on a first-come, first-served basis as commitments are finalized.

Permanent Legacy Recognition

Founders are permanently recognized within the new building on an elegant Legacy Wall, thoughtfully designed to honor those whose commitment helped shape the next chapter of Garland Mountain. Founder names will be displayed in a timeless format.

Newsletter Recognition

Founding Members will be publicly acknowledged in Garland Mountain communications, including a formal recognition within our club newsletter distributed to tens of thousands of Garland Mountain subscribers as the opening of the new facilities approaches. This acknowledgment is intended as a collective expression of gratitude and recognition for those who helped shape the next chapter of Garland Mountain.

Priority Dining Reservations

Founders receive priority dining reservation access for the Garland Mountain restaurant on high-demand dates such as Mother's Day, Father's Day, Valentine's Day, and similar peak periods. For these occasions, Founding Members will be offered an exclusive advance reservation window, providing the opportunity to secure preferred reservation times and seating, where available, prior to reservations opening to the general public.

Priority Access to Cart Fleet

Founders receive priority access to Garland Mountain's fleet of carts during peak periods and special events. On high-demand days, Founding Members may reserve a cart in advance by contacting the club, typically the day prior to their visit. Reserved carts will be held and available upon arrival at the designated time, ensuring a seamless and reliable experience even during our busiest periods.

Founders' Privileges and Recognition

Annual Private Room Privilege

Founding Members are granted the privilege of reserving Garland Mountain's designated private meeting room, also suitable for private dining, for one hosted gathering per year. Designed for business meetings or family celebrations, use of the room offers Founders a distinctive and comfortable private setting within the club.

Founders Annual Dining Credit

Three-Year Dining Privilege – \$850 Annually (\$2,550 Total Value)
Each Founding Member receives an annual \$850 dining credit, for three years, to be enjoyed within the new Garland Mountain restaurant.

Founders Annual Shooting Credit

Three-Year Shooting Privilege – \$850 Annually (\$2,550 Total Value)
Each Founding Member also receives an annual \$850 shooting credit, for three years, applicable toward standard sporting clays target fees at Garland Mountain.

Founders Shooting Vests

Each Founding Member will receive six custom Garland Mountain-branded shooting vests. These vests provide a refined, consistent presentation for corporate entertaining, client outings, and hosted experiences, while serving as a visible mark of member distinction.

Economic Perspective

Under conservative assumptions, Founding Members typically reach economic break-even in approximately five years, with meaningful value realized in the first three. This analysis excludes the value of permanent naming recognition, priority access privileges, and legacy recognition.
